How we are making digital transformation of Ukraine?

- The Ministry of Digital Transformation has been founded for the first time in the history of Ukraine. It shapes digitization policy in Ukraine.
- The Digital Transformation Committee, as a profile committee in the Parliament of Ukraine, makes legislative policy in Ukraine.
- Local (domestic) digital initiatives (in each ministry and regional administrations) will be implemented by CDTO (Chief Digital Technology Officer).





Single State eServices Portal is available round the clock to provide any public service without queues and bureaucracy. If the service is not available online, it won't exist in a paper-based format.

- The architecture that will become basis for all eServices has been developed

- Citizens' eCabinet (access to information about ourselves from state registries (5)

To introduce in the Ministries and other central governmental authorities of executive power the position of Deputy Head of respective authority on digital development, transformation and digitalization (CDTO).

CDTO - Chief Digital Transformation Officer - Deputy Minister (Deputy Head of governmental authority), who coordinates the digital transformation and is responsible for the electronic registries, processes and services.

CDTO is not an IT specialist, but digital transformator with deep vision in the sector.

Diia.Business Project

- National online-platform for entrepreneurs was launched on February 28th, 2020 (more than 97.000 site visitors)
- First in Ukraine entrepreneurs support center Diia. Business was "technically opened" on May 28, 2020 in Kharkiv, official opening happened on July 1st, 2020

Diia.Digital Education Project

- 22 educational serials were filmed and uploaded to online-platform
- More than 266.000 Ukrainians registered for digital skills education
- We built the network of more than 1300 digital education hubs

4G internet

High-speed mobile 4G internet launch in 900 MHz band and will be available for countryside citizens. Till July 2022 4G internet will be available for 90% of citizens of Ukraine.

Development and approval of the draft of the Law "On electronic communications". Telecom market activity rules reforming

Other fields

Tax Code updates in communications field. Development of the draft of the Law on the access to infrastructure of construction objects, transport and electrical energy industry

700 MHz, 800 MHz and 900 MHz

Detachment of 700 MHz, 800 MHz and 900 MHz bands from television and special users. Release of promising frequencies for new technologies introduction

Telecommunication regulator

Development and approval of the draft of the Law on national regulator in the field of telecommunication. Creation of independent regulator in the field of communication to ensure the unified state policy implementation Social infrastructure

Social infrastructure facilities connection to high-speed Internet. Internet in all schools, libraries, government authorities and other social infrastructure institutions
